



# Life or Death?

"This is the Torah: when a man dies in a tent, all who come into the tent and everything in the tent shall be impure for seven days." [19:14]

From this seemingly benign verse that details the laws of impurity caused by a corpse, R' Shimon ben Lakish derives a vital lesson for the living.

"How do we know that Torah only lasts within one who kills himself over it? Because it says, 'this is the Torah: a man who dies in a tent..." (Talmud Brachos 63b)

While this gemara seems to teach a nice lesson in dedication, it presents a problem. Elsewhere, the Torah says, "V'chai bahem, you should live by the words of the Torah." (Vayikra (Lev.) 18:5)

Which one is it, asks the Chafetz Chaim: Is the Torah a source of life or something to die for?

The Chafetz Chaim answers in his inimitable way, with a story. There was once a business owner who took the "busy" of his business very seriously. He was always working: Morning, evening and night. Overburdened, he enlisted his wife's support in the business as well until the two of them virtually did nothing more than work. This hectic and singularly focused lifestyle continued for many years until one sunny morning, sometime past middle-age the man looked in the mirror. What he saw scared him- it was faint, but he could clearly see the shadow of the angel of death peeking out from between his thinning gray hairs.

On the spot he resolved to devote the rest of his life to his real work- accruing the merchandise he would take with him into the next world. He left his house,

passed by his office, and headed straight for the Bais Medrash, and opened up a gemara. A few blessedly fulfilling hours later, his wife frantically burst into the room, "Where were you?!"

"The store is full of customers and I can't possibly manage! Tell the books to wait!"

Seeing his wife's desperation, he rushed to the store to help out. This pattern continued for a few days until the man decided it was time to have a talk with his wife.

"My dear wife, he began over a cup of steaming tea, let me ask you: If the angel of death came and told you that he was coming for me would you tell him to wait until the customers are gone?!"

Not waiting for a reply the man concluded, "Every morning, pretend I died and was thus unavailable. Would you then mind if I show up a few hours later?!"

This is R' Shimon ben Lakish's lesson to us. The Torah is our life- no doubt. But to really live a life of Torah sometimes we just have to play dead!
